Happy 30th anniversary to the P. Buckley Moss Society! It seems like just yesterday that the Society was formed, but here we are, thirty years later. I would like to thank each of you for your dedication and support through the years—many of you have been members from the beginning, 1987!

In the past thirty years, you have helped raise over \$3,762,438 for organizations nationwide through donations of my art via the Charity Print Collection; over \$2,246,161 to benefit charities through raffles, auctions, sales of chapter cookbooks, Bingo parties, donations, and a wide range of other fundraisers; over \$105,900 in direct scholarship aid; and over \$200,000 to LDA, the Panama Schools Project, the Red Cross, and other charities. In addition, you have helped establish and support the P. Buckley Moss Foundation for Children's Education to promote the integration of the arts into all educational programs, with a special focus on children who learn in different ways. Congratulations!

We continue to grow and expand our charitable reach and are looking forward to working with new members who share our ideals and goals. It's always fun to work together for a common goal!

One of the Society's first members was Sally Case—her

membership number was #14. Sally represented my work at Vivian's Antiques and Collectibles in Columbiana, Ohio, since before the Society was formed and was an active member in several chapters, including her local Essence of Moss Chapter. Sally didn't fly, but she never thought twice about driving for hours through multiple states to attend Collectors' Conventions, Dealers' Meetings, and Barn Shows. I considered Sally to be one of my oldest, dearest friends, and it saddened me greatly to learn that she passed away last August. She will be missed!

A Letter from Sandy Moore, President of the P. Buckley Moss Foundation for Children's Education

The following is an important message from Sandy Moore, President of the Foundation:

"Without our Moss Society chapters working to promote the philanthropy of Pat Moss and her Foundation for Children's Education, we know that our work with children's education would not make the strong impact that it does. All that you do is valued and appreciated so very much. In 2017 we are going to be refreshing and growing our efforts, and we know that this is going to help you and also the Foundation. As we start the year, we have an immediate need for your help.

"The P. Buckley Moss Foundation for Children's Education annually grants a \$1,000 scholarship to a high school senior with financial need, a certified language-related learning difference, and artistic talent who plans a career in the visual arts. The student is eligible to renew the P. Buckley Moss Endowed Scholarship for an additional three years, provided the student maintains a "C" average and takes art classes each semester. The funds to cover this scholarship come from interest earned on restricted funds donated for this purpose. Due to low interest rates over the past several years, the interest earned is not sufficient to cover the scholarship awards.

"In past years, various local Moss Society chapters have donated to the Foundation to assist with the Endowed Scholarship awards. The Executive Board of the P. Buckley Moss Foundation would like to encourage all Society chapters to consider making a donation toward this purpose. In addition, if individuals would like to donate funds to support the scholarship awards, their donations would qualify as IRS tax deductions. Please note, the donated funds would be used immediately to fund scholarship awards and would not go into the restricted endowment fund. Contributions should be sent to the P. Buckley Moss Foundation for Children's Education at 108 S. Wayne Ave., Waynesboro, VA 22980, and earmarked for the Endowed Scholarship Emergency Fund.

"It is the utmost wish of the Foundation to be able to continue this scholarship to honor P. Buckley Moss and all she has done to assist individuals who learn differently. The Foundation would like to sincerely thank the Moss Society chapters for all they do to promote the philanthropic endeavors of Pat Moss."

Society E-mail Address Change. The Society's e-mail address has changed from society@mossociety.org to society@pbuckleymoss.com.





Chapters Continue Charity Efforts, Activities

CENTRAL IOWA Chapter (Des Moines, IA) members celebrated their 25th anniversary in 2016. Their annual charity luncheon raised \$2,626 through live and silent auctions as well as a *Perfect Perch* print donated by the Society's Charity Print Program. James Moore donated time and materials for invitations and tickets, and the Chapter gave him a \$50 gift card. The Sweet Adeline Quartet provided entertainment during the luncheon, and the Chapter donated \$150 to them. Additional donations included \$50 as well as art supplies to the After School Arts Program (ASAP), \$500 to the P. Buckley Moss Foundation for Children's Education in honor of Pat's birthday, and an additional \$65 to the Foundation to sponsor a child to attend the Summer Art Enrichment Program held in Waynesboro, VA. Chapter members also made fleece blankets that were distributed to Youth Emergency Shelter Services (YESS) and "adopted" three YESS children at Christmas, providing \$402-worth of clothing and presents.

HEART OF IOWA Chapter (Ames, IA) members held their annual Charity Tea in 2016. The theme was "Seasons of the Heart", and they cleared a total of \$2,350 through ticket sales and a raffle of several items. Of that amount, \$689 was raised via the raffle

of a remarked *Flowers of Summer* Moss print donated by the Society's Charity Print Program. The framing was donated by the Country Gallery of Ellsworth, IA. The lucky winner of the print was Cecilia Horner. A check for \$2,350 was presented to Friendship Ark of Ames, which is an organization that provides group housing and programming for adults with intellectual disabilities. They have five homes in Ames, and the donated funds will be used for a stair lift for one of them so that all the residents can access the lower level for recreation, games, etc.

In addition, Chapter members donated \$250 to the South Hamilton School District teacher's foundation, which they used to purchase lunchtime milk for needy students. Chapter members also made fleece blankets for Project Linus and completed nineteen blankets to be given to children in hospitals, domestic assault shelters, cancer treatment centers, etc. The estimated value of the blankets is over \$250. An additional \$175 was donated to the children's section of their public library in loving memory of a member who passed away.

The Chapter decided to disband at the end of the year, and we thank them for their service and dedication.

LAKE MARBURG MOSS Chapter (Hanover, PA) members supported Fisher House by providing items for families of patients at Walter Reed Bethesda Naval Hospital (veterans and military families) in 2016 by collecting requested/needed items. Chapter members also supported Santa's Sleepers, a local project that provides a warm pair of pajamas for local children. The pajamas are distributed to various organizations in town so no child is without a warm pair of pj's. The Chapter collected sixty sets of pj's and donated an additional \$145 to be used toward the sizes needed. Chapter members also donated \$200 to New Hope Ministries and \$200 to Hope Lives. Both local programs assist battered women and children in the community.

MOSS IN THE COUNTRY Chapter (Daleville, VA) members acquired a remarked *Baylor's Mill* print from the Society's Charity Print Program in 2016 and raffled it to benefit the Botetourt Resource Center. Framing was donated by Apple Barn Gallery, and the proceeds were \$2,076. The lucky winner was Lottie Crowder of Daleville. Chapter members also donated \$200 to St. Francis Service Dogs, \$200 to the P. Buckley Moss Foundation for Children's Education, \$50 each to two local high schools for their After Prom Parties, \$20 to Relay for Life (purchased luminary bags in memory of deceased chapter members), crackers and soup to Soup for Seniors, \$100 to UNC Day 4 Girls (mission group), and \$200 to a walk-a-thon for cancer research.

MOSS IN THE FOREST Chapter (Forest, VA) members donated \$257 to Wheels on the James for the purchase of an AmTryke therapeutic cycle in 2016. The money was raised from an internal raffle of a Moss item donated by a chapter member. Wheels on the James is a non-profit charitable organization that provides custom-made cycles to individuals with physical challenges. They also collected food and clothing for the

Salvation Army in Lynchburg, VA; donated clothing and personal items to the YMCA Domestic Violence Center; and donated sewing supplies, material, and personal items to the Wings Program hosted by Gleaning for the World. The Wings Program has volunteers who sew and make feminine hygiene kits for teenagers and women in developing countries.

MOSS IN THE MOUNTAINS Chapter (Princeton, WV) members obtained a remarked print of *A Peaceful Place* from the Society's Charity Print Program in 2016 and conducted a raffle. The framing was donated by Frameworks Plus of Princeton, WV. The lucky winner was Vickie Honaker. The proceeds of \$1,000 were donated to Young Life-Bluefield, which is an organization of caring adults who interact with teenagers on "their own turf" and mentor them. The organization also provides a youth camp, and the Chapter's donation will cover the cost of two participating campers.

MOSS ON THE JAMES Chapter (Richmond, VA) members held their 9th Annual Tea Party in 2016 at the County Seat Restaurant in Powhatan, Virginia. The beneficiary of the related fundraising activities was Mesa Vista Therapeutics Farm located in Powhatan, which offers therapeutic horseback riding for

children and adults with a range of physical, emotional, cognitive, and social special needs. The Chapter raised \$6,075 via the tea party and associated fundraising activities, including ticket sales, a silent auction, a raffle, and a portion of the proceeds from the sale of Pat's print *Promise of Spring*. \$1,369 of the total amount raised was from the raffle of *The Filly*, which was framed by The Beveled Edge of Glen Allen, VA, and donated by the Society's Charity Print Program. Chapter member Barbara Dyke was the lucky winner. The funds were used to purchase a special riding saddle that will accommodate riders who need full support while riding the horses.

Chapter members also obtained a remarked print from the Society's Charity Print Program, which was also framed by The Beveled Edge, and conducted a raffle to benefit the Sprites Heroes Chapter of Paws to Read. A total of \$1,450 was raised, and Chris Miller was the lucky winner of the framed print.

In addition, Chapter members volunteered at the Valentine Ball for C.J.'s Thumbs Up, which provides assistance to the families of seriously ill children; made floral arrangements in tea cups to be used as decorations for their annual Tea Party and then donated them to the Massey Cancer Center; donated several bags of toiletries to the MCV Hospitality

House; and also supported the Moss Collectors' Convention in Williamsburg, VA, by volunteering, donating a goodie basket to the silent auction to benefit the Moss Foundation for Children's Education, and attending Chapter Training.

MOSSAPHILE Chapter (Atlanta, GA) members obtained a remarked *Appalachian Winter* Moss print from the Society's Charity Print Program in 2016 and conducted a raffle. The framing was donated by The Framery of Marietta, GA. The proceeds of \$1,050 were donated to the P. Buckley Moss Foundation for Children's Education, along with an additional donation from the Chapter of \$100. The winner of the print was Bonnie-Lou Binnig. A second Moss print was donated by a chapter member, and John Bott was the lucky winner of that one. An additional donation of \$50 was made by the Chapter to the Moss Foundation in the memory of Mossaphile member Doris Maisel.

The Chapter also donated \$50 to Snax Sax, a local program sponsored by Embry Hills United Methodist Church in which volunteers donate, package, and deliver food to needy students attending neighborhood schools. Food bags containing healthy snacks are delivered to the schools for students to take home over the weekend. Chapter members also donated canned and other non-perishable goods to the Atlanta Community Food Bank, as well as gently used clothing and new undergarments and socks to The Atlanta Mission. In addition, the Chapter supported the Moss Collectors' Convention in Williamsburg, VA, by donating a goodie basket to the silent auction to benefit the Moss Foundation for Children's Education and attending Chapter Training.

P.B.'S PALS Chapter (Collinsville, IL) members conducted two fundraisers in

2016, raising \$1,215 for P.E.O. chapters IK and ML and \$300 for the local Tote Me Home program.

THREE RIVERS MOSS Chapter (Pittsburgh, PA) members awarded four scholarships of \$500 each in 2016. In addition, Chapter members donated gift bags of spa shampoos, conditioners, body gels, and body lotions to a women's shelter.

TREES OF LIFE Chapter (Defiance, OH) members raised a record high \$33,310 for their September 18, 2016, benefit for Luke Haselman, a three-year-old suffering from Acute Lymphoblastic Leukemia (ALL). The event was an encore performance of "Defiance Has Talent and Heart", with a theme of "Christmas Was Made for Children". There were fifteen entries (singers and a dance group), who all performed favorite Christmas songs. The crowd of 530 people "voted" by placing donations in a bucket for their favorite entertainer. The show was hosted by the town's favorite radio celebrity and also included a buffet dinner. In addition

to the donations collected, funds were raised through a silent auction, the live auction of a beautiful nativity sketch created by Pat, a 50/50 drawing, and an October raffle calendar that included eighteen prizes. The top prize was a *Peace in the Valley* giclée donated by the Society's Charity Print Program and framed by The Corner Gallery of Archbold, OH. This was the Chapter's sixth year of doing the popular "Defiance Has Talent and Heart" event.

In addition, the Chapter provided supplies for gift bags for the Family Justice Center and donated \$100 to Christmas for Kids/ Tiana's Wish in honor of D.J. Rick Small being the emcee for the Defiance Has Talent fundraiser. Some members also participated in a local Relay for Life event to benefit the American Cancer Society as well as a "Conquer Childhood Cancer" Glow-Walk to raise funds for area children with cancer.






